<p><b>Did you buy or sell a house or vacation property?</b> If so, review existing and new insurance carriers to see if there is a benefit to changing insurance carriers.</p>	<input type="checkbox"/>	<input type="checkbox"/>
<p><b>Does your homeowner's insurance cover less than 80% of the home's replacement value?</b> If so, increase the coverage limit as the insurance carrier may not fully cover the cost of damage caused by an insured event. <p><b>Have you made substantial capital improvements to the property (such as a swimming pool, addition, or renovation)?</b> If so, consider the following:</p> <ul style="list-style-type: none"> <li>Check that your insurance covers a minimum of 80% of the replacement value of the house.</li> <li>Additional liability protection may be needed.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<p><b>Has the value of the property increased substantially since the last time you reviewed your homeowner's coverage?</b> If so, consider checking that your insurance covers a minimum of 80% of the replacement value of the property.</p>	<input type="checkbox"/>	<input type="checkbox"/>
<p><b>Do you need to add (or make the insurance carrier aware of) smoke detectors, security systems, and fire extinguishers?</b> If so, consider the discount you may receive by having those listed on your homeowner's policy.</p>	<input type="checkbox"/>	<input type="checkbox"/>
<p><b>Have you reviewed changing the deductible?</b> If so, this could decrease (or increase) your premium.</p>	<input type="checkbox"/>	<input type="checkbox"/>

<p><b>Do you own real estate that you rent to tenants?</b> If so, consider the following:</p> <ul style="list-style-type: none"> <li>Review property and liability protection to ensure it is adequate.</li> <li>Additional coverage may be needed to cover vandalism and loss of rent due to a covered event.</li> <li>If liability protection is a primary concern, consider the possible use of an LLC.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>

<p><b>Do you need to review whether increasing or decreasing your deductible is appropriate?</b> If so, consider the replacement value of your car, your personal risk tolerance, and your emergency funds before making a decision. <p><b>Do you have any children on your auto policy?</b> If so, consider the following:</p> <ul style="list-style-type: none"> <li>Check to see if you are eligible for any good student discounts.</li> <li>If you have a part-time driver (such as a college student), you may be eligible for a discount.</li> <li>Check to see at what age they will be required to leave your policy.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
